3. <u>REPORT</u>: Consent Decree Agreement with San Diego Coast-keeper and Coastal Environmental Rights Foundation for Four Wastewater Treatment Facilities

Rania Amen and Juan Guerreiro gave a presentation regarding the City's intent to request approval from the San Diego City Council on October 16 to enter into a

Consent Decree Agreement with San Diego Coastkeeper and the Coastal Environmental Rights Foundation, to resolve all claims for the alleged violations of the NPDES General Permit for Storm Water Discharge Associated with Industrial Activities, Order No. 2014-0057-DWQ. A copy of the presentation is included with these minutes as Attachment A.

Five City owned facilities are involved in the action, four of which are Metro facilities:

- Point Loma Wastewater Treatment Plant
- South Bay Water Reclamation Plant
- North City Water Reclamation Plant
- Metro Biosolids Center

This action arose when elevated levels of bacteria during storm events were noticed by Coastkeeper that were posted on the City's Smart system.

Juan gave an overview of what actions the City of San Diego plans to take over the next five years to correct the containment of storm water and the range of costs involved associated with the alternatives. The City plans to present the plan to Coast Keeper and share with them the timeline for corrective actions if approved by the San Diego City Council.

**ACTION:** Motion by Frank Rivera, seconded by Yazmin Arellano to send this item forward to Metro Commission/JPA in October. The motion was unanimous.

### 6. <u>REPORT</u>: Update from Regional Wastewater Disposal Agreement Flow Commitment Working Group

There was no report this month.

### 7. REPORT: Update from Sample Rejection Protocol Working Group

Edgar Patino reported that he and his staff are still working on the strength based billing workshop which should be presented over the next few months. Chula vista has requested a one on one to update new employees an familiarize them wit strength based billing.

### 8. Metro Wastewater Update (standing item)

There was no report this month.

### 9. Pure Water Program Update

John Helminski handed out a Pure Water Actions Items project schedule for between now and June 2019. This is included as Attachment B to these minutes. The first item is the WIFIA Funding Authorization that will be going to the San Diego City Council on 9/25/18. PUD staff is very pleased as WIFIA increased their funding support to their maximum which is 49% of project costs or \$614 million. The City's design consultant is still working on the Phase 2 project alternatives and most likely they are looking at a November for completion of the report. The smaller PA working group will be meeting with the project team in October to review the draft. Work is still continuing on cost analysis with the cost allocation working group. Due to the fact that the San Diego Council Committee has moved their meeting to November 1<sup>st</sup>, which is the same day as the regular Metro Commission/JPA, there may need to be a special Metro Commission/JPA meeting on October 25.

### 10. Metro Capital Improvement Program and Funding Sources (Standing item)

The FY2018 Capital Improvements Projects (CIP) Report – 4th Quarter was attached to the agenda and Edgar Patino asked if there were any questions. Tung Phung was asked to review the status of the South Bay Demineralization project and the cost overruns associated with the Pump Station 2 Power Reliability and Surge Protection projects at the November 2018 Metro TAC meeting,

### 11. Financial Update (Standing Item)

Karyn Keese reported that the FYE 2017 fieldwork had started on Monday, September 17, and the initial work should be completed this week. Dexter Wilson will be joining her in the audit to review the four Pure Water CIP's and the Pure Water Program O&M task orders. She was happy to report that during FYE 2017 the City of San Diego had received the proceeds from a Bureau of Reclamation grant of \$5 million. 32% had been allocation to Metro or \$1.6 million. She will be reviewing the determination for this allocation of revenues between water and wastewater during the course of the audit. It is expected that the FYE 2017 audit will be completed by May 2019.



- South Bay Water Reclamation Plant
- North City Water Reclamation Plant
- Metro Biosolids Center

### **Fiscal Impact by Year**

- \$100,000 for SDCK & CERF fees and costs (within 45 calendar days of Order)
- \$35,000 to fund Environmental Project (within 45 calendar days of Order)
- \$25,000 capped monitoring fees (annually not to exceed five years)






